WCCE Temporary Service Reductions due to COVID-19

The Washington County Commuter Express will be temporarily suspending runs 5 and 20 beginning on Monday, November 2, 2020 through Friday, December 4, 2020. WCCE is seeing an increase in drivers who have been exposed to COVID-19 in their private lives. Out of an abundance of caution, drivers who have been in a close contact with a confirmed case are being asked to quarantine 14 days before returning to work. **There have been no confirmed cases of COVID that can be linked to riding or driving the WCCE bus.**
